



Section 1 - Application Fee

Application Fee of THB 5,000 per child is payable when an application is submitted and is a non-refundable administration charge.

Section 2 - Entrance Fee

The Entrance fee is payable upon initial enrolment and confirmation of the place at the school. This fee is non-refundable. Two options are below:

a) Entrance Fee: One-Time Lump Sum Fee

b) Capital Levy fee

Capital Levy is an alternative method of paying the enrolment fee. This allows parents who stay in Thailand for only a short period of time to have a reduced enrolment fee. The capital levy of THB 20,000 per term per child is charged termly for the first 6 consecutive terms (or equal to the maximum of capital levy of THB 120,000).

Section 4 – General Deposits

Section 11 – School Fee Refund

A refund of tuition fee, canteen fee and transportation fee will only be granted depending on the following conditions: “When a child leaves the school before the next term starts, the parents will be refunded a full term. If the child starts a new term, the parents will be refunded for half term’s fees if the child leaves before the half term break. However, if the child attends the second half term but leaves before its end, there is no refund”.
